A. Call the regular monthly meeting of Council to Order 7:OOPM

Mayor MacDonald called the meeting to order with a quorum.

B. Agenda

2.1 Approval of Agenda

Motion by C. Thibodeau and seconded by C. MacDonald to approve the agenda as circulated in advance of this meeting. All in favour. Motion carried.

D. Approval of Minutes – March 13, 2017 & March 22, 2017.

Motion by C. MacDonald and seconded by C. Dunphy to approve the minutes of March 13, 2017 and March 22, 2017 as prepared by CAO with no errors or omissions. All in favour. Motion carried.

E. Monthly RCMP Report (March 2017)

RCMP officer Ian Allen was present. March was relatively quiet with just 23 call within the Town of Souris. 1 impaired driver, 5 check stops, 1 inncodent of bullying. Cst Allen spoke at SRS. Cpl Holland is currently on medical leave. Sgt position is currently vacant. New Sgt Chris Gunn to start May 13th. Sgt Gunn is very traffic orientated.

In response to C. MacDonald's concern over telephone system at Souris office Cst Allen said unfortunately the automated system is here to stay.

They've looked into the 911 Bike Run coming to PEI in June and have no concern as riders are from various emergency responder organizations. Not outlaw bikers.

Mayor is concerned that RCMP visibility is limited on side streets and would like to see more of it. Cst Allen informed Council of new unmarked car that is in the area.

Planning/Development:

K. Robin Croucher has applied for permission to revise the boundaries of his commercial property #648907-000. A preliminary drawing is attached for your reference.

Motion by C. Dunphy and seconded by C. MacDonald to approve Robin Croucher's request to revise the boundaries of his commercial property by subdividing off a small portion of his residential property and adding it to his commercial property. An official survey plan will need to be submitted for final approval. All in favour. Motion carried.

L. Camilla (John) MacPhee is applying to consolidate PID #101873 & 101881 in to one (1) property. It was recommended that Council grant permission to Camilla & John MacPhee to consolidate these

two properties into one.

Motion by C. Dunphy and seconded by C. Thibodeau to approve the consolidation of these two properties. All in favour. Motion carried.

- M. Royal Canadian Legion Branch No 3 has submitted a development application to undertake significant restoration to the Legion building on Main Street. The only significant change to their existing setback will be an added four feet to the front. It still leaves them over the minimum required setback for the front. Stamped architect plans will be provided once completed. It was recommended that Council approve this development application for significant restoration to the Legion Building on Main Street as proposed.
 - **Motion** by C. Dunphy and seconded by C. Cheverie to approve the development application from Souris Legion for restoration of the Legion building on Main Street as per the specification provided. All in favour. Motion carried.
- N. Application from Frank & Kimberly Ahlering to subdivide and acquire a portion of PID 103291 from A.E.MacPhee. (The old rink property) They are proposing to subdivide approximately 12,240 sq ft leaving the existing property with an approximate size of 8,856 sq ft. The Ahlering's future plan for the newly subdivided property is to develop a tourism/accommodation type business. The property is currently zoned Commercial.

It was recommended for approval of this subdivision. Both properties will still be over the minimum size for commercial properties. Additional details would be required for development of the accommodation structure(s) prior to development. This recommendation is for the subdividing of the land only. But all agreed that tourism accommodations are needed within the Town. (Patsy McInnis abstained from voting due to conflict of working with A.E. MacPhee) All in favour. Motion carried.

Motion by C. Dunphy and seconded by C. Thibodeau to give preliminary approval to Kim and Frank Ahlering for the subdivision of PID# 103291. Confirmation of ownership and official survey plans will need to be submitted for final approval. All in favour. Motion carried.

Motion by C. MacDonald and seconded by C. Cheverie that we donate \$250 plus lapel pins for each participant. All in favour. Motion carried.
