L. Request from Souris Legion to put a large war memorial monument on recently donated land on the corner of Main Street and High Street. Pictures of the monument and location are attached. Although this is not a building it is a large enough structure to warrant acquiring a permit and approval by Council.

MOTION by C. Peters and seconded by C. MacDonald to approve the application for the installation of this memorial monument. Parking will be available at Main Street Mall. All in favour. Motion carried. (C. Dunphy abstained from this vote due to conflict)

M. Application to operate a Business from Stephanie Mitsuk (O'Brien) at 151 Main Street. The proposed business of esthetics is a permitted business in a residential zone. No exterior alterations or additions to be made.

MOTION by C. Peters and seconded by C. Thibodeau to approve this permit to operate a business within the Town. An esthetics business is an allowable business within a residential home. An added parking space will be made to provide adequate parking. All in favour. Motion carried.

- N. Application to operate a Business from Kate Henriques at 116 Main Street. The proposed business of a flower & gift shop. 116 Main Street is a commercial property.

 MOTION by C. Peters and seconded by C. MacDonald to approve this permit to operate a business within the Town. 116 Main Street is in a commercial zone. Council suggested a parking plan be

Kathy Rooney & Keir Kenny represented the Souris Show Hall Foundation. They are requesting the Town's support for a liquor license and also for an Island Innovation Fund application they are submitting for funds to do work on the building. They see the Souris Show Hall and the old Leard store as a future cultural facility with an art gallery, rental space and film school. Part of the application process is a letter of support from the municipality.

MOTION by C. MacDonald to provide the requested letter of support for the funding application. No seconder. Mayor asked 3 times for a seconder; none provided. The motion died on the floor. Councillor Thibodeau suggested that they get at least one successful year of operation under their belt and then Council will reconsider their request for support.
