#### E. Monthly RCMP Report (November)

Cpl. Les Dill represented RCMP with summary report from November. Highlights: more check points; cell phone violations are up from Nov'15; mental health calls tend to go up this time of year and they can consume a lot of time, they keep an officer tied up for several hours; PEI RCMP now carry antidote kits for fentanyl as it needs to be administered as quickly as possible, Cpl. Dill asked if Fire Department considered carrying them as first responders?

MOTION by C. MacDonald and seconded by C. Bailey to accept the report as presented by Cpl. Dill. All in favour. Motion carried.

**F. Proposal from Eastern Media to lease Matthew McLean 2<sup>nd</sup> Floor Office Space** (Wallace Rose) Wallace & Lisa Rose from Eastern Media presented Town Council with a proposal for renting 2<sup>nd</sup> floor office space at Matthew McLean Bldg. They currently represent Montague, Murray River, Cardigan,

Eastern Kings and Souris. They have been involved with recent PEI Connectors Bus Tour, attended several workshops, seminars, etc with a goal of promoting Eastern PEI to newcomers and new business. They propose a 1 year reduced sliding scale rent with potential to sub-lease extra space. Any sub-lease amounts received would go to the Town in addition to what Eastern Media is committed to pay for year one.

Councillor Cheverie will review current costs, particularly electricity, for the building to make sure we wouldn't be taking a huge loss. Decision to be carried forward.
