A. Call the regular monthly meeting of Council to Order 7:OOPM Mayor O'Brien called the meeting to order with a quorum. All Council were present.

B. Agenda

2.1 Approval of Agenda

MOTION by C. Peters and seconded by C. Cheverie to approve the Agenda as prepared. All in favour. Motion carried.

2.2 Additions to Agenda

MOTION by C. Peters and seconded by C. Cheverie to add: Brian Deveau to update on Boardwalk Extension project. All in favour. Motion carried.

C. Conflict of Interest Declaration

Part VI, Section 23 of the Municipalities Act, which maintains that no member of Council shall derive any profit or financial advantage from his/her position as a member of Council and, where a member of Council has any pecuniary interest in or is affected by any matter before the Council, shall declare his/her interest therein and abstain from voting and discussion thereon. No conflict declared.

D. Approval of Minutes – June 11, 2018.

MOTION by C. Thibodeau and seconded by C. Dunphy to approve the minutes of June 11, 2018 as prepared and distributed by CAO prior to this meeting without errors or omissions. All in favour. Motion carried.

E. Monthly RCMP Report (June 2018)

Representing the RCMP was Cst. Jeremy Johnson. Report included: increased activity during summer months, participated in East Point Lighthouse Run, kindergarten children were at department for a tour, Canada Day Flag raising and Fireworks, two impaired drivers, 54 call all together during the month of June.

C. Cheverie questioned the crosswalk at the Beach. Did the RCMP feel the signage was sufficient? Are there set regulations? Cst. Johnson will look into it, but felt it may be more of a provincial highway safety issue.

MOTION by C. MacDonald and seconded by C. Peters to adopt the monthly RCMP report as presented. Summary of calls report was provided to Council. All in favour. Motion carried.

ADDITION: Brian Deveau was present to update Council Boardwalk project and ask for financial support from the Town.

The committee found out that plans prepared by David MacAulay with Cahill's construction can be signed off by an engineer. The Province will give \$7,500 to hire a planner/designer in order to acquire permits, funding, etc. We would have to contribute 15% (\$1,125).

MOTION by C. Dunphy and seconded by C. Cheverie that we agree to contribute the 15%. All in favour. Motion carried.

The Province has upped their contribution to the project to \$100,000. ACOA may be in for 50% of the anticipated \$400,000. That would leave \$100,000 balance to be funded.
