#### D. Presentation of 2017 Audited Financial Statements (by MRSB)

Statements were presented by Michelle Burge of MRSB.

MOTION by C. Thibodeau and seconded by C. Peters to approve the 2017 Audited Financial Statements as prepared and presented by MRSB. All in favour. Motion carried.

E. Presentation of 2018-19 Town of Souris & Water & Sewer Utility Budgets (by Finance Chair Denis Thibodeau). As per the new PEI Municipal Government Act, we will be presenting a 15 Month Budget with a year end of March 31, 2019.

**Presented by C. Thibodeau** Highlights include: No Municipal Tax rate increase; new Municipal Expenditure Capital Grant included in Revenue; we will be using some of the firetruck/equipment reserve fund to purchase much needed compressor for fire hall; more work to be done at gateway park; wage increase of 3% for employees of the Town; we will be applying to IRAC for a possible increase in water & sewer rates.

**C. Thibodeau** thanks all Council and especially the CAO and Patty Rose for all their work in preparing and managing our budgets.

**MOTION** by C. Thibodeau and seconded by C. Cheverie to approve the 2018-19 Operating Budget for the Town of Souris and the Water and Sewer Utility Corp. as presented March 28, 2018. All in favour. Motion carried. (copy of Budget attached to minutes)

## F. Appointment of 2018-19 Auditors
