A. Call the regular monthly meeting of Council to Order 7:OOPM Deputy Mayor J Dunphy called the meeting to order with a quorum.

E. Monthly RCMP Report (September 2019)

Cst. Sonet Sato presented monthly report to Council. September seen the start of the school year. Two charges of passing a school bus within the Town. It's been busy month with 51 calls. Five-year Gas Tax Capital Expenditure Allocation (\$690,372): Breakwater Street Sewerage Lift Station \$572,000 Walking path/sidewalk on MacPhee Avenue \$118,372 Motion by Council required to support application. **MOTION** by C. Chaisson and seconded by C. Peters to support the application of these projects for our Gas Tax Five Year Expenditure Allocation. All in favour. Motion carried.

- G. Carried forward: Application from Lighthouse Baptist Church to put a small cemetery on their property. Notification was sent to neighbouring properties. A couple of responses were received. MOTION by C. Chaisson and seconded by C. I. MacDonald that we do not approve this development application due to it being so close to our wellfield protection zone; and because having a cemetery within an industrial zone is not deemed compatible or appropriate use. CAO will send a response to the applicant identifying the reasons it was not approved.
 All in favour. Motion carried.
- H. Carried forward: Interest from Jackson Holding Inc AND April/Daryl Gregory to purchase PID 103275 currently owned by the Town of Souris. (corner of Federal Ave and Washington St.) They are the adjacent property owners. Land could be subdivided and split between interested parties at a fair market price. The property was purchased by the Town in 2007 for a project that did not proceed. It is currently being used for parking and/or green space. CAO is working on finding value of this property.
