# A. Call the regular monthly meeting of Council to Order 7:OOPM

**Interim Mayor JoAnne Dunphy** called the meeting to order with a quorum at 7:00pm.

#### E. Monthly RCMP Report (August 2019)

Sg. Chris Gunn presented monthly report to Council. Two tickets were issued recently for passing a school bus while lights were flashing. Minimum \$1,000 fine + 12 demerit points + loss of license depending on driving record. Flashing speed monitoring signs have been posted at the French school in hopes of slowing traffic down through school zone. MOTION by C. T. MacDonald and seconded by C. Bailey to accept the report as presented. All in favour. Motion carried.

## G. Resignation of Mayor. Dates for By-Election

Mayor Steve O'Brien submitted his resignation to our CAO August 14, 2019. According to Municipal Government Act (MGA) we are required to hold a by-election to fill this position.

**MOTION** by C. Peters and seconded by C. Chaisson that we schedule accordingly to have our By-Election Monday, November 18, 2019. All in favour. Motion carried.

#### **Planning/Development:**

- M. Application from Lighthouse Baptist Church to put a small cemetery on their property. MOTION by C. Peters and seconded by C. Bailey that we send notification to property owners within 500 sq.ft. of this property for input. This item will be tabled until October meeting in order to allow time for this notification and response. All in favour. Motion carried.
- N. Application from Paul & Connie Westman to operate a Bed & Breakfast from their home at 57 Chapel Ave., Souris

**MOTION** by C. Peters and seconded by C. Bailey to provide a permit to Paul & Connie Westman to operate a Bed and Breakfast from their home at 57 Chapel Ave. Proposal meets requirements as per our zoning and development bylaw pertaining to the operation of such business. All in favour. Motion carried.

#### New Business, Correspondence, Requests and/or Additions:

O. Agreement from Infrastructure Secretariat for \$2,419,890 funding for Souris Wastewater Treatment Plant Facility Upgrades. Requires approval by Council.

**MOTION** by C. T. MacDonald and seconded by C. I. MacDonald that we sign the ICIP agreement for this funding. All in favour. Motion carried.

Also,

**MOTION** by C. T. MacDonald and seconded by C. Bailey that we engage CBCL as our engineers for this ICIP project. All in favour. Motion carried.

P. Agreement to transfer responsibility to the Province of PEI for administration and enforcement of the new Building Code Act, S.P.E.I. 2017, c.61. Requires approval by Council.

**MOTION** by C. Chaisson and seconded by C. T. MacDonald that we transfer responsibility to the Province of PEI for administration and enforcement of the new Building Code Act, S.P.E.I. 2017,c.61. All in favour. Motion carried.

Q. Interest from Jackson Holding Inc AND April/Daryl Gregory to purchase PID 103275 currently owned by the Town of Souris. (corner of Federal Ave and Washington St.) They are the adjacent property owners. Land could be subdivided and split between interested parties at a fair market price. The property was purchased by the Town in 2007 for a project that did not proceed. It is currently being used for parking and/or green space.

Council recommended that CAO try to determine the fair market value of the land and what it would cost to have it surveyed and subdivided. If immediately adjacent property owners are not interested it could be posted for sale to the general public? Once value is determined Council will be notified prior to any proposals or offers being made.

R. Opportunity to have Electric Car station or stations installed in partnership with Maritime Electric and the Province.

Council decided not to participate in this partnership. The Province is installing a fast-charging station at the Irving on Main Street in Souris.

S. Call for nominations for the FPEIM Board.

**MOTION** by C. Chaisson and seconded by C. Bailey to nominate JoAnne Dunphy as our representative on the FPEIM Board. The position was left vacant when Mayor O'Brien resigned. JoAnne agreed to be nominated. All in favour. Motion carried.
