A. Call the regular monthly meeting of Council to Order 7: OOPM

Mayor Dunphy called the meeting to order with a quorum.

2.1 Approval of Agenda

MOTION by C. Leard and seconded by C. Chaisson to approve the Agenda as circulated prior to meeting. All in favour. Motion carried.

G. PRELIMINARY BUDGET REVIEW FOR 2020-21 AS PREPARED BY COUNCIL AND CAO

CAO reviewed the preliminary budgets. Budgets were put together by both Council and staff. Council are urged to take some time to review the budget. Planning/Development:

M. Information regarding new Building Permit procedures put in place with the adoption of the National Building Code by the Province of PEI.

Effective March 2020 anyone that plans to develop/build within the Town of Souris will now require a second permit from the Province of PEI for the actual construction. The Town will still have the say in what gets build where, but the actual construction will be followed up by Provincial Inspectors. The Province will not issue a construction permit until the applicant has received a development permit from the Town of Souris. (There is a one-year delay for single family homes and duplexes until March 2021)

N. Power Lifting Championship request for Sponsorship.

MOTION by C. Thelma MacDonald and seconded by C. Peters to donate \$200. The event was scheduled for April 18, 2020. CAO will be in contact with the organizers to see if the event will be cancelled or rescheduled prior to issuing the cheque. All in favour. Motion carried.

O. Breakwater Street Lift Station - Tender review and recommendation from CBCL

MOTION by C. Ian MacDonald and seconded by C. Leard to award the project to the lowest tender in the amount of \$647,900 received from Island Coast Services as per recommendation from our engineers CBCL. This is about \$31,000 over the estimated budget. Three bids were received. C. Ian MacDonald questioned the number of days to complete the project as it was higher than the next bid. CAO added that CBCL considered this as well, but they feel the number of days proposed is reasonable for the project. We are also having a clause added to the tender, for the successful bidder to sign, regarding concerns around COVID-19.
