MEETING WILL BE HELD IN THE COUNCIL CHAMBERS

IT WILL BE OPEN TO THE PUBLIC, HOWEVER, DUE TO COVID-19 RESTRICTIONS STILL IN PLACE FOR LARGE GATHERINGS NO MORE THEN 15 PEOPLE CAN BE IN THE COUNCIL CHAMBERS AT ONE TIME. CAO WILL SET UP COUNCIL CHAMBERS TO SPACE EVERYONE OUT TO ALLOW FOR PHYSICAL-DISTANCING

A. Call the regular monthly meeting of Council to Order 7: OOPM Mayor called the meeting to order at 7pm with a quorum. All Council were present except Councilor Kenny Peters.

B. Agenda

2.1 Approval of Agenda MOTION by C. Leard and seconded by C. Bailey to approve the agenda as circulated to Council prior to this meeting. All in favour. Motion carried.

2.2 Additions to Agenda We have a proposal from Lindsey Ross for space available at Gateway Park

C. Conflict of Interest Declaration

Part VI, Section 23 of the Municipalities Act, which maintains that no member of Council shall derive any profit or financial advantage from his/her position as a member of Council and, where a member of Council has any pecuniary interest in or is affected by any matter before the Council, shall declare his/her interest therein and abstain from voting and discussion thereon. No conflict was declared.

D. Approval of Minutes – June 8, 2020

MOTION by C. T. MacDonald and seconded by C. Bailey to approve the minutes of June 8, 2020 as prepared by CAO. All in favour. Motion carried.

Presentations:

E. Monthly RCMP Report (June 2020)

Cst. Paynter presented monthly report to Council. COVID-19 has consumed a fair bit of their time over the past few months. ATV's are a problem that they are trying to deal with. RCMP has access to off-road vehicles but training would be required. 2 impaired driving charges last month. C. Bailey brought up damage that has been happening at St. Mary's Church property

(the grass area below the parking lot). RCMP will be doing extra patrols of the area. They have limited members and are spread pretty thin between Montague and Souris. MOTION by C. T. MacDonald and seconded by C. Chaisson to accept the RCMP report as presented by Cst. Paynter. All in favour. Motion carried.

F. Presentation by Frank MacEachern Re Community Trails Pilot Project

Mr. MacEachern presented a very enlightening presentation. It is proposing a Pilot project to the Province that would encourage more use of our Confederation Trails. He feels municipalities can build on the project by making their communities more bike friendly. Public Washrooms, bike racks, water bottle filling stations, wifi, signage, accommodations, etc. He feels it needs to be a regional effort, not individual municipalities.

He would like a letter of support as well as representation from Council on an Action Committee. MOTION by C. Leard and seconded by C. T. MacDonald that we provide a letter of support. All Council felt this was a very good idea. C. Leard offered to be our representative on the committee. All in favour. Motion carried.

(Active Transportation Fund may help with making roads more bike friendly.)

Business arising from previous meetings:

- G. Public Consultation from Bell for the installation of a 30m high telecommunication tower at 9 Sterns Avenue. This type of development is regulated by Industry Canada. However, they are requesting input from the Town.
 - Input was sent following our May meeting as recommended by Council. A response was received and will be reviewed at meeting for further discussion.
 - At our June meeting is was suggested by Council to arrange a meeting with Bell reps.
 - A virtual meeting was held with Jess Harper and representatives from Bell and an alternative location was suggested. New public notification will have to take place pertaining to the alternate location. (on Town land beside the salt/storage building on Pond Street)
