A. Call the regular monthly meeting of Council to Order 7: OOPM

B. Agenda

2.1 Approval of Agenda

MOTION by C. Leard and seconded by C. Bailey to approve the Agenda as circulated prior to this meeting. All in favour. Motion carried.

D. Approval of Minutes – September 14, & 23, 2020

MOTION by C. T. MacDonald and seconded by C. Peters to approve the minutes of both September 14 and September 23, 2020 meetings without any errors or omissions. All in favour. Motion carried.

E. Monthly RCMP Report (September 2020) Sgt. Darryl MacMullan

Council welcomed Sgt. Darryl MacMullan. This is Sgt. MacMullan's 7th posting in 13 years. Sgt. MacMullan reporting that speeding is a major concern of RCMP on PEI. There were 15 check points held over the long weekend. He also hopes that PEI will bring back the drug unit as he feels drugs are becoming or is a major concern. RCMP needs the public's help. Call the RCMP or Crime Stoppers if you are aware any illegal drugs or any criminal issues.

F. Souris Beach Gateway Park Boardwalk Update (Brian Deveau)

Brian Deveau updated Council on success of boardwalk extension. Many positive comments, many people walking on boardwalk. Committee would like to consider another extension that would connect the boardwalk to the beach. First a meeting with Environment and Wildlife should be set up to see if we can get approvals. And then we can work on funding. With sources available it is hoped that the proposed extension could be done without contribution from the Town.

Brian also brought up a donation of a rail-tie that was donated by the Gallant family. They would like to see it on display along the boardwalk. We will ask Town Maintenance department if they can come up with a possible placement.

Brian Deveau as part of the Boardwalk committee will invite stakeholders to review and see if an extension would be considered.

MOTION by C. Leard and seconded by C. Peters that Brian Deveau pursue this possibility with government officials, in particular those we would require approvals from. Representatives of Council will be part of any meetings set up for review and discussion. All in favour. Motion carried.

Planning/Development:

N. Sale of Land at Corner of Washington Street and Federal Avenue

Background. . . . Prior to COVID and prior to the devasting fire at the Bluefin Restaurant Amber Jenkins of Jackson Holdings and April & Daryl Gregory were going to jointly purchase the property at the corner of Washington Street and Federal Avenue currently owned by the Town of Souris. As the Town of Souris determined they do no have use and would be willing to sell at a fair market value. Since then Amber Jenkins of Jackson Holdings has decided she no longer has interest in purchasing a portion of the property.

April & Daryl Gregory have however since expressed interest in the entire piece of property. They are asking if Council would reconsider the asking price. Originally it was to be \$15,000 split between the two entities. Would Council consider reducing this slightly to \$10,000 or \$12,000?

MOTION by C. Leard and seconded by C. Bailey that we propose \$12,000 as our asking price. When we had the property assessed by a local realtor it was suggested that the price should be in that range. CAO will respond to April & Daryl Gregory with this offer. All in favour. Motion carried.
