A. Call the regular monthly meeting of Council to Order 7: OOPM

Mayor Dunphy called the meeting to order with a quorum. All Council present.

C. Conflict of Interest Declaration

M. Request for donation to Souris Lions Club Christmas Box Campaign

MOTION by C. Chaisson and seconded by C. T. MacDonald that we donate \$500 towards the 2020 Souris Lions Club Christmas Box Campaign. All in favour. Motion carried.

N. Snow Plowing Bid from Chapmans and Winter Services Agreement to supply sand from the Province.

MOTION by C. Chaisson and seconded by C. Peters that we accept the bid proposed by Chapman Bros for snow plowing and from the Province to supply sand for the 2020-2021 season. All in favour. Motion carried.

O. Correspondence from JJ Chaisson regarding turning point on LaVie Avenue

MOTION by C. Peters and seconded by C. T. MacDonald that CAO and Maintenance Staff investigate what could be done to improve this situation. All in favour. Motion carried. (C. Chaisson abstained from discussion and vote)

P. Correspondence from Billy Gallant, manager of MacIntyre House Group Home regarding speeding and dangerous traffic on Church Avenue.

RCMP have been made aware of this very serious concern and plan to increase patrols of the area during the times this reckless driving has been reported. If necessary, charges will be issued.

Q. Correspondence from SHAI regarding larger than normal Water bill due to a break in their water line at the wharf.

MOTION by C. Leard and seconded by C. Peters that we reduce SHAI water bill by \$5,000. Discussion was held on the circumstances of the water break. It was noted that SHAI are actively trying to prevent future breaks and loss of water, even to the point of purchasing their own meter reading device so they would know sooner if it were to happen again. 4 Votes Yes, 1 Vote No (C. Chaisson felt it should be reduced more than \$5,000 and therefore voted no to the motion) (Councillor Ian abstained from discussion and vote) Motion carried.
