# E. Monthly RCMP Report – July 2023

Written report made available to Council. Currently 2 officers are off on sick leave. We have a new district commander. 4 new officers coming to the district. C. Mitsuk asked again about a presentation to parents regarding drugs.

# F. Presentation by local ATV Club

Peter Mellish, President of the PEI ATV Federation will be attending the meeting with Eddie. He will speak to getting permission for road access to obtain goods and fuel. He will provide background on how this works for the other existing eight ATV clubs as well and answer any

queries. Eddie, President of the Souris Trailriders ATV Club Inc. #9 will also be seeking an extension beyond September 30, 2023 for the clubs use of Clinton Ball Field parking area.

Currently there are 500 km of trails across PEI. 8 active ATV Clubs. They will have their own unique mapping system. The Province supports their efforts as they see Tourism benefits. They are requesting access to certain streets within the Town to enable users to access fuel, goods, services, etc.

They are requesting a letter of support. They are planning public consultation. It would be nice to see the Town of Souris to be known as an ATV friendly Town. Or a Trail Town.

#### G. Presentation by Group seeking support in principle for Community Wellness Facility.

More details shared via Sharepoint August Council Meeting.

Ashley Sherbanuk presented on behalf of this group. They are seeking Council support in principle for a new Wellness Facility for the area. Although they have done quite a bit of research, met with other organizations, and visited other new facilities across the Island, they are still in the early stages. The 3 main pillars for their vision of this Community Wellness Facility are Recreation, Learning & Community. No cost has been determined or location at this point. They will be seeking government support to hire a consultant.

Planning Board recommends denying this application due to required setback not being met. A variance is not recommended as it is located on corner/intersection lot. Required setback to a property line on a street side is 15'; plans provided showed 12.9'setback. **Council** is willing to consider if the applicant is able to meet the required 15' setback. CAO will advise.

# New Business, Correspondence, Requests and/or Additions:

Q. Appraisal of all Town Properties was completed for insurance purposes. A summary of appraised values and increase to our insurance premiums is attached.

The appraisal was done by a 3<sup>rd</sup> party appraiser.

**MOTION** by C. Mitsuk and seconded by C. Outhouse that we adjust our property values as per recommended by appraiser and adjusted premiums to match these values. All in favour. Motion carried.

It was also noted that this appraisal was for structures only, not the contents. We should also look at updating the value of contents. CAO will look into this, what it would entail, and the cost associated.

**MOTION** by C. Outhouse and seconded by C. Chaisson that we extend our current agreement with the local ATV Club to use Town land near the Clinton Ballfield for parking/unloading ATV's. All in favour. Motion carried.

**MOTION** by C. Chaisson and seconded by C. Outhouse that the Town of Souris support the local ATV Club with a \$5,000 Tier 1 sponsorship that will include signage. All in favour. Motion carried.
