A. Call the regular monthly meeting of Council to Order 7: OOPM

E. Monthly RCMP Report – August 2023

Sgt. M. Robinson attended the meeting. Reviewed report. Copies of RCMP August report included in Council package. 10% of the calls were in the Town of Souris area. Their cars are being equipped with cell service boosters to enhance service in rural areas where it can be limited. Noted that they (RCMP) welcome calls from the public anytime. As of Friday, September 8^{th} , no further update, or information is available. CAO has requested Lawrence MacAulay's office inquire as to when we may expect a response as the 4-6 months has now passed.

GICB Application was submitted February 28, 2023. Expected timeline for a decision is 4-6 months. Status of this application is still under review.

I. Location of new Dog Park to be confirmed.

Discussion was held. Council agreed they would like the space to be as large as possible. This location will allow for a water line to be installed. C. Mitsuk suggests moving the existing J. MacCormack sign to open that space for the dog park. Utilizing the fence that already exists. Potentially making it 60' x 250' or larger if possible. The J. MacCormack sign can be relocated. C. Laybolt seconded this motion. All in favour. Motion carried.

Q. Appointment of Auditors for 2023-24 Fiscal Year

R. CCBF Allocation. The Town of Souris currently has approximately \$138,000 of unallocated CCBF (Gas Tax) Funds. To receive the funds, we are required to allocate them to a project. It is recommended that we allocate to an existing project. This will save having to go through an approval process. The monies can always be reallocated (to another eligible project) if Council chooses to do so.

Currently, we have approved projects for "Upgrades to the Eastern Kings Sportsplex", "Wind Turbine at Treatment Plant" and "Wastewater Sustainability Project".

MOTION by C. Leard and seconded by C. Jenkins that move the unallocated CCBF funds into the "Wind Turbine at Treatment Plant" project. All in favour. Motion carried.
