## A. Call the regular monthly meeting of Council to Order 7: OOPM

Mayor Dunphy called the meeting to order with a quorum. Councillor Chaisson was absent from the meeting.

## E. Monthly RCMP Report – January 2024

#### F. Presentation by Souris Show Hall Foundation.

Request for funding and support along with an update regarding the mortgage and renovation plans. To be clear we are not looking for money for renovations, or infrastructure, but some ongoing support. *Further details, presentation and information will be provided.* 

Ms. Kathy Rooney and Ms. Judy Burke were present to update Council on what's been happening at the Souris ShowHall.

They had a great 2023 season and 2024 is shaping up to be even better. They have secured funding for major renovations, but they are hoping for support to help with everyday operating expenses. They feel what they are doing in the community fits well into the Town's goals outlined in our Official Plan. Their numbers were up 70% from the previous year. They will continue to provide high quality but affordable entertainment for all ages. They currently have 4 board members and are hoping to engage more, especially locals to join. They especially enjoyed participating in local events such as our Souris Christmas Parade Festival and look forward to it again in 2024.

Council thanked them very much for their presentation and advised them they will take their request into consideration when preparing their 2024-25 Budget.

**H. Innovation Communities Fund/ACOA** (Dog Park, Ballfield Upgrades, Rink Roof, Matthew McLean Bldg Upgrades)

We have until March 14<sup>th</sup> to spend any balance left in this grant. A couple of items to be considered include:

- New flooring at VIC (quote received from MM Flooring to recover with wood look plank vinyl), Evergreen Dining space floor is quite bad as well. (It has also been refinished a couple of times)
- Small storage building for Skateboard/Tennis Courts.

**MOTION** by C. Outhouse and seconded by C. Laybolt that if approved by ACOA, we revise the statement of work for this project to include these items. All in favour. Motion carried.

### I. Heat Pumps for Matthew McLean Building. Potential Funding from Rural Development.

Funding is available for heat pumps. But no action has been taken.

Council wanted first to get recommendations and quotes for updating the existing geothermal system. See attached.

C. Leard asked about tons per unit? CAO will ask proponents.

As per quotes provided, this is a very big and very expensive project. CAO will investigate potential funding sources to help with such a project.
