# E. Monthly RCMP Report – March 2024

Mike Robinson with the RCMP presented their report of calls during the month of March 2024 within the Town of Souris and area.

In all of Kings District there were 575 calls, 44 of which were in the Town of Souris. Overall we have a low crime rate. No serious crimes. Fraud is still one of their largest files. There is a request on the table for a dedicated Fraud Investigation Officer(s) for PEI. They continue to work on traffic safety with regular traffic stops. There is currently an active drug investigation happening within Kings District, but little details can be made public at this time for the protection of the case. Currently Kings

District is short 6 of the 24 positions/members either due to retirement, pending new officers to fill the positions or medical leave. They are actively working to fill those positions with 3 potentially coming in June.

MOTION by C. Laybolt and seconded by C. Outhouse to accept the RCMP report as presented. All in favour. Motion carried.

# Business arising from previous meetings:

# F. Option analysis for EK Sportsplex - revised scope of work

Further discussion was held on how we should revise this scope of work. Some things to be considered should be: potential of reviving the bowling lanes, putting together a committee moving forward, working with SeaRoots Alliance for the same goals. Working with rink staff, rink board of directors, town council, and other stakeholders.

It was agreed that we move forward with our Option Analysis as planned, so we would have necessary answers to questions.

MOTION by C. Mitsuk and seconded by C. Laybolt that we move forward with our proposed Option Analysis based on this discussion. All in favour. Motion carried.

Q. Housing shortage and potential development of vacant lots/houses.

Councillor Laybolt brought up concerns about the shortage of housing in our Town and the potential for some vacant lots/houses to be made into housing. In particular the old RCMP houses in Souris on Union Avenue and LaVie Avenue. It is a shame to see them sitting empty when so many people are without adequate housing. Should we consider looking at a vacant property bylaw like the City of Summerside? Maybe this would incentivize people into restoring them or possibly selling them. We should talk to CBDC Eastern PEI to see what incentives or initiatives they may have to promote development.
