# Q. Dangerous, Hazardous and Unsightly Premises Bylaw #2024-08

Reviewed and drafted by R. MacGregor at "McInnes Cooper Law Firm" Draft Copy of amended bylaw available for review.

Moved by C. Outhouse and seconded by C. Mitsuk

WHEREAS AS PER THE MUNICIPAL GOVERNMENT ACT, R.S.P.E.I. 1988, Cap. M-12.1 Section 180, a council may pass bylaws and provide services for municipal purposes respecting. (i) nuisances, loitering, dangerous or unsightly property, noise, pollution and waste in or on public or private property. And WHEREAS Council has had their legal counsel review this bylaw update/amendment to ensure it meets with the level of authority as given to municipalities within the Municipal Government Act.

**And WHEREAS** if adopted this bylaw #2024-08 would replace or repeal any other Dangerous, Hazardous and Unsightly Premises Bylaw previously adopted by the Town of Souris.

Be it resolved that Town of Souris Dangerous, Hazardous and Unsightly Premises Bylaw #2024-08 be hereby read a first time.
