#### F. Monthly RCMP Report – October 2024

No representative from the RCMP was available to attend our meeting.

Some concerns were raised by Council. Concerns included, future of Souris Office, a councilor was told of someone not getting a response from call to RCMP, youth crime rate is reported to be higher, lack of RCMP presence in Town. CAO will request a meeting with RCMP for Council to discuss these concerns.

#### G. Website update.

C. Mitsuk and C. Outhouse have prepared and forwarded some new content for the updated website. CAO will request a virtual teams meeting with AOR to see where we are with the update.

### H. Request from Eastern Kings Sportsplex for Financial Support

Carried forward from October 15, 2024 meeting.

This request comes following notification of a major increase in Insurance premiums for the EK Sportsplex. Over the past few years, the amount has tripled. This increase is based on an updated valuation of the building and its contents.

MOTION by C. Leard and seconded by Jenkins that we give \$10,000 in financial support to the Sportsplex as requested.

Discussion

- C. Outhouse suggested we revise the motion with a contingency that the Board of Directors of the rink come up with a fundraiser (different from what they already do) to raise \$10,000 and the Town would then match it. − C. Leard is worried if we don't provide them with the financial support they asked for it will seem as we are not supporting them as a board. − C. Mitsuk feels that since the Insurance has been already paid for by the Town, them reimbursing the Town is not urgent, that we still have time to work with them and they are currently insured. A new policy or operating terms would help everyone and hopefully prevent them feeling overwhelmed or burnt-out. From C. Mitsuk's perspective she just wants to be assured they are making an effort in the fundraising or revenue generating area. Support and partnership have been offered. − C. Mitsuk also feels we should wait to see what their response was from their latest meeting. Mayor was made aware the board has reached out to Souris West and Eastern Kings for support as well. − C. Leard asked about Recreation PEI support. Also, what about unincorporated areas? And why has the "Arena" grant given to rinks from the province not increased over the years, it actually was reduced.

A vote was taken, C. Leard & C. Jenkins in favour of Motion. C. Laybolt, C. MacPhee, C. Mitsuk and C. Outhouse not in favour. Motion defeated.

Request to carry forward to our December meeting. More information may be available at that time to be reconsidered.

# New Business, Correspondence, Requests and/or Additions:

### P. Snow Clearing Services – Quote for 2024-25 Services

Copy of bid from Chapman Bros. Construction for snow clearing services and spreading sand (sand supplied by Town)

MOTION by C. Laybolt and seconded by C. Leard to approve the bid from Chapman Bros. Construction for snow clearing services and spreading sand for the 2024-25 Winter. Total including HST is \$145,327.26 (3% increase from previous year) All in favour. Motion carried.

### Q. Proposal from CBCL to undertake an assessment of Town owned buildings.

This will utilize funds we originally received from RGI for option analysis for EK Sportsplex but Council decided to reallocate since SeaRoots Alliance is planning to do a feasibility study.

MOTION by C. Outhouse and seconded by C. Laybolt that we reallocate these funds to a building assessment study of Town owned buildings as proposed by CBCL. All in favour. Motion carried.

# R. Request from Souris Fire Department Members for Gym Membership

The firefighters would like to propose the Town pay 50% of the cost of gym membership for them at our local Eastern Fitness Centre. This is something that could come from their Training or Recreation Budget. Liz from our office has contacted Eastern Fitness and they have offered a corporate rate of \$500 per year. At this time approximately five firefighters are interested.

MOTION by C. Mitsuk and seconded by C. Leard that we support this initiative for the Souris Fire Department to offer reduced cost gym memberships to our firefighters. EK Fitness has offered a corporate rate of \$500 per year. 50% of that will be paid by the Town for each firefighter that wants to join. All in favour. Motion carried.

## S. Request from Souris Lions Club for Donation to Christmas Box Campaign

MOTION by C. Outhouse and seconded by C. MacPhee that we donate \$1,000 to the Souris Lions Club for their Christmas Box Campaign. C. Laybolt, C. Jenkins & Mayor Dunphy declared conflict. All in favour. Motion carried.

#### T. Canada Community Building Fund (CCBF)

Due to a miscalculation in our funding agreement with CCBF we are currently over-committed. The error occurred within their system. We are still getting the same amount going forward as recently announced, however we will need to revise some project contributions from CCBF. Total amount to be uncommitted \$101,783.19

It was recommended that we table this to our next meeting to give the EK Sportsplex Board a chance to give their input into whether we put the funding towards the Roof or the Compressors. The Province has agreed to do one or the other. Both are of similar cost and urgency.
