#### A. Call the regular monthly meeting of Council to Order 7:OOPM

**Mayor Dunphy** called the meeting to order with a quorum. All Council were present. Still one vacant seat on Council. By-Election will be held March 2, 2020.

#### C. Conflict of Interest Declaration

**MOTION** by C. T. MacDonald and seconded by C. I. MacDonald to approve the minutes of December 10, 2019 as prepared by CAO without errors or omissions. All in favour. Motion carried.

#### **E. Monthly RCMP Report** (December 2019)

RCMP representative was presented to review past months calls. They plan to do a "Did you Know" campaign to educate people on what charges are possible for various offences.

## F. Expression of Interest for Senior's Development on Anniversary Ave. Proposal from Justin MacKenzie and Melody MacInnis to be considered.

**MOTION** by C. T. MacDonald and seconded by C. Chaisson that we accept the proposal received from our EOI from Justin MacKenzie and Melody MacInnis to develop 26 units for Seniors Housing on

the Town owned land off of Anniversary. Council have a concern that 26 units may not fit on the 2.96 acres of land. A development application with a site plan will need to be reviewed by our Planning Consultant as well as our Planning Advisory Board prior to permit approval.

All in favour. Motion carried.

### G. Amendment for increase in Nomination Fees for Municipal Elections.

**MOTION** by C. Peters and seconded by C. MacDonald that we give **first reading** to our amendment to the Town of Souris Elections By-law 2018-01. This amendment would increase the nomination deposit from \$10 to \$100 with conditions set out for refund eligibility. A second reading is required prior to the end of January if this amendment is to be in effect for our March 2, 2020 By-Election. Mayor will notify Council and the Public of this date as soon as it is determined.

Council felt this amendment would encourage candidates to work harder in order to become elected. And that the \$100, nor the 15% of votes required for refund should deter anyone from putting their name forth.
