A. Call the regular monthly meeting of Council to Order 7: OOPM

Mayor Dunphy called the meeting to order with a quorum. All Council were present. Members of Souris Show Hall Foundation and SeaRoots Alliance were also in attendance. Along with RCMP representative and Kyle from the Graphic. MLA Robin Croucher. Also, some members of the public.

B. Agenda

2.1 Approval of Agenda

MOTION by C. Leard and seconded by C. MacPhee to approve the Agenda as prepared and circulated prior to the meeting. All in favour. Motion carried.

2.2 Additions to Agenda

No additions noted.

C. Conflict of Interest Declaration

Part VI, Section 23 of the Municipalities Act, which maintains that no member of Council shall derive any profit or financial advantage from his/her position as a member of Council and, where a member of Council has any pecuniary interest in or is affected by any matter before the Council, shall declare his/her interest therein and abstain from voting and discussion thereon.

No conflict declared.

D. Approval of Minutes – December 9, 2024, Council Meeting

MOTION by C. Mitsuk and seconded by C. Jenkins to approve the minutes of December 9, 2024 Council Meeting as prepared by CAO and circulated to Council prior to this meeting. All in favour. Motion carried.

Presentations:

E. Monthly RCMP Report – December 2024

M. Robinson of the RCMP presented the monthly report for December. Copies were made available to Council.

MOTION by C. Laybolt and seconded by C. MacPhee to approve the RCMP monthly report as presented. All in favour. Motion carried.

F. Presentation from Souris Show Hall Foundation

A handout was provided to Council. CAO will file with January meeting attachments.

Judy Burke and Grace Cameron presented on behalf of the Souris Show Hall. The Show Hall is seeking \$10,000 a year and a commitment to continued funding so long as the Souris Show Hall meets its commitments to the Community.

MOTION by C. Mitsuk and seconded by C. Laybolt to defer this request for consideration as part of the 2025-26 budget planning process. All in favour. Motion carried.

G. Presentation/Request from SeaRoots Alliance to support Comprehensive Feasibility Study

A very informative presentation was made by Ashley Sherbanuk with SeaRoots Alliance. Other members of their group were also in attendance. (Keisha, Their presentation to Council was to encourage the Town Council to provide \$15,000 that would be used towards a Comprehensive Feasibility Study and Business Plan for a new Wellness Centre for the Community. Their presentation highlighted several areas including how such a facility would alignment with Town Priorities, including our newest Official Plan, Economic Benefits, Regional Collaboration and Shared Benefits, External Funding and Support, Social Benefits, as well as Infrastructure Benefits. The study proposed would also include looking for options of what could be done with the existing Eastern Kings Sportsplex (which if the Town was to undertake on their own could cost \$10,000 - \$15,000 alone).

They also made a change to their RFP to include the location for a new facility after realizing that a good portion of the initially proposed plan location is considered a "no development" zone due to it being within the Town's Wellfield Protection 250 day zone. Considerations for this will be included and alternative locations, potential zoning changes, will be identified within the study.

Questions and Discussion:

- C. Mitsuk asked if looking for alternative locations will they only be considering locations within the Town? Or outside the Town? SeaRoots responded that they would only look outside the Town if left with no options within. For many reasons it would be beneficial for it to be built within the Town. C. Mitsuk also asked if needed are they willing to purchase land? SeaRoots responded, yes, if needed to make it work.
- C. Leard asked about the breakdown of \$15,000 from the Town and \$1,000 from 3 surrounding communities. He feels it is unfair and he uncomfortable putting it all on the taxpayers of Souris. Some, but not all businesses, would benefit from this type of development. SeaRoots responded that they feel the Town of Souris has the most to gain and that by them including the options for the existing rink, which alone could cost several thousand dollars, they do not feel the breakdown is unfair. They expressed that they want to work collaboratively with everyone to make this happen and will work towards a smooth transition throughout.
- C. Mitsuk also talked about the breakdown. If we go by population of the 4 incorporated areas, it will work out to about \$7.60 per person, which is not how it is broken down. However, now feels more comfortable with the reasoning, and if asked, could explain it.
- C. Leard still has hesitations and worries the Town will end up having to take over, like in the past, but supports the feasibility study.
- C. Laybolt has concerns over the two groups (SeaRoots and EK Sportsplex) both fundraising at the same time. SeaRoots explained how they will collaborate and not compete as they also understand it is important to keep the existing Sportsplex running until a new Wellness Centre is completed.

MOTION by C. MacPhee and seconded by C. Mitsuk to approve the request of \$15,000 from SeaRoots Alliance to be used towards a Comprehensive Feasibility Study and Business Plan for a new Wellness Centre for our Community. Council feels this study will provide answers to a lot of questions and give everyone a good understanding of what is required moving forward.

CAO will determine the correct terminology for the resolution required for our support of the Feasibility Study based on what is required by funders. SeaRoots representative Ashley Sherbanuk will confirm.

Vote was taken, 5 in favour, 1 not in favour. Motion carried.

H. Website update.

Work on Website is still ongoing. New content has been prepared by Councillors Mitsuk and Outhouse.

I. RGI Application for Funding – Eastern Kings Sportsplex

Quotes received for compressors are being summarized by CBCL for budgeting purposes. The application is ready to be submitted once the budget is determined.

CAO has been in contact with a consultant from MRSB that could potentially help us in the preparation of this document. They will be supplying us with a proposal including scope of work, cost, etc. within the next week.

T. Active Transportation Fund proposed projects

Trails that would connect what we have now to areas such as the Farmer's Market, Dog Park and Ballfields. More walking trails with lights. Bike rest stops with shelters, possibly near T-3 bus stops, more bike racks. Carpool Parking area.

MOTION by C. Outhouse and seconded by C. Laybolt that we submit an application to the AT Transportation Fund by January 17th with these ideas in mind. CAO will check to see if design or consulting fees would be eligible in order to build a plan for new trails. All in favour. Motion carried.

CLOSURE OF BOARDWALK – Council suggests that we should clarify within the advertisement of the Boardwalk Closure that the closure includes the Boardwalk and provide alternative walking locations.
