A. Call the regular monthly meeting of Council to Order 7: OOPM Mayor Dunphy called the meeting to order with a quorum.

Councillor Boyd Leard joined us via speaker phone (from his hospital room- where we are happy to hear he is continuing to recover from major surgery, we look forward to having him back in person soon)

Councillor Peters was not able to attend – sends his regrets. All other Council were present.

B. Agenda

2.1 Approval of Agenda

MOTION by C. Leard and seconded by C. Bailey to approve the Agenda as circulated to Council prior to this meeting. All in favour. Motion carried.

C. Conflict of Interest Declaration

MOTION by C. T. MacDonald and seconded by C. Chaisson to approve the minutes of May 9, 2022 public meeting as prepared by CAO without any errors or omissions. All in favour. Motion carried.

E. Monthly RCMP Report – May 2022

Cst. Cote attended as representation of RCMP. Cst. Cote is based out of Montague.

The RCMP continues to work within the community to enhance relationships with organizations, seniors, schools, etc. As always Impaired Driving is a priority. They try to be proactive by having road checks, etc. They encourage the public to call if they suspect someone is driving impaired or if they are witness to any illegal or criminal acts that could endanger the public or property. MOTION by C. Leard and seconded by C. T. MacDonald for appoint Donnie Aitken as the new Fire Chief for the Souris Fire Department. C. Leard felt Donnie will do an excellent job as Fire Chief as he has a significant amount of experience and skills that will be an asset to our department in his role as Chief. We are fortunate Mr. Aitken has put his name forth for this position and look forward to working with him. Donnie was present at the meeting for this appointment. All in favour. Motion carried.

DEVELOPMENT/BUSINESS – APPROVAL REQUIRED:

- M. Application from Matthew Rice for a Private Garage. Planning Board to review and make recommendation prior to this meeting as the proposed development is over 500 sq ft.

 MOTION by C. Chaisson and seconded by C. Bailey to approve the development application submitted by Matthew Rice for a Private Garage as recommended by Planning Advisory Board. Matthew is required to also get a Building Permit from the Province and has been made aware by CAO. All in favour. Motion carried.
- N. Application from Habitat for Humanity to sub-divide their property at 9 High St. Planning Board to review and recommend prior to meeting.

MOTION by C. Bailey and seconded by C. I. MacDonald to preliminarily approve the application from Habitat for Humanity PEI to subdivide their property at 9 High Street as recommended by Planning Advisory Board. For final approval they will be required to submit required copies of a certified survey plan showing the subdivision of the land to our CAO which will need to be stamped by PEI Land registry office and the Town of Souris. All in favour. Motion carried.

New Business, Correspondence, Requests and/or Additions:

O. We should start the next step to search for possible funding for an effective solution to protect our coastline and our beach area. The intertidal reefs made of rock to control erosion by armouring the beach face and dissipating wave energy has proven to be saving our beach.

MOTION by C. Leard and seconded by C. I. MacDonald that we lobby the Province to build additional intertidal reefs at Souris Beach to further protect the shoreline and causeway. The existing rock reefs seem to be working. Maybe we could contact UPEI Climate school to investigate the benefits of the existing reefs?

All in favour. Motion carried.

P. Resolution required for hiring an engineer for rink roof project fund from rural growth initiative program. 50% funding up to \$16,000 (estimated cost to be \$32,000) They would inspect rink roof, prepare bid documents, review and recommend on bids received and monitor construction at various phases. We have applied for additional funds from the Province and ACOA for the actual construction.

MOTION by C. T. MacDonald and seconded by C. Bailey to support this application to RGI program for 50% funding to hire CBCL to inspect, prepare bid documents based on findings, review and recommend on bids received and monitor construction. This work needs to be done prior to roof replacement project funding is acquired so that we are ready to go to tender ASAP. We are still hopeful ACOA will provide funding for this project and also hope that the Province will help. All in favour. Motion carried.

Q. Request for Sponsorship from Rollo Bay Fiddle Festival

MOTION by C. T. MacDonald that we donate \$300 towards the Rollo Bay Fiddle Festival, C. Chaisson asked to increase the donation to \$500 which would put us in the Bronze level of sponsorshop, C. I. MacDonald seconded C. Chaisson's motion for the \$500. All felt it was an important year to support the festival especially following a couple of tough years during the pandemic. All in favour. Motion carried.

R. Request for Sponsorship from Tuna Cup Challenge

S. Request for support from Artisans on Main.

Council decided not to support this request for financial support as \$1,790 is a large amount and not something we have in our budget for this year. Something this large would need to be budgeted for. We can support them in any other way including promoting their events, etc. CAO will notify Artisans on Main of this decision explaining Council decision.
