C. Thibodeau noted that there is approximately \$27,000 left from the deck project that could be used. He will also review budget to see if any other dollars could be redirected towards our share of the boardwalk extension. ACOA and the Province are eager to move forward but want to spend their money before March 31, 2019.

Upon inspection by Town staff it was found that the extension closest to the corner of Church Ave was not within the minimum required. Harbourview has revised their extension to meet the minimum. Revised drawing is attached to application.
