Some things included: securing Souris.ca for Town of Souris; set up an office in the matthew mclean building; support many small businesses and organizations; welcome to eastern kings baskets delivered to several new comers to our area; promoting a strong web presence for the area; Ceilidhs.com; weekly online newsletter of events; they are also working on a Winter Festival.

Montague, Cardigan, Murray River, are involved and they are working with St. Peters and Eastern Kings.
