## A. Call the SPECIAL COUNCIL Meeting of Council to Order/AND Land Acknowledgement @ 6:30PM

Mayor Dunphy called the meeting to order with a quorum and read land acknowledgment.

In the spirit of Reconciliation, we acknowledge that the land upon which we gather is unceded Mi'kmaq territory. Epekwitk (Prince Edward Island), Mi'kma'ki, is covered by the historic Treaties of Peace and Friendship. We pay our respects to the Indigenous Mi'kmaq People who have occupied this Island for over 12,000 years; past, present and future.

### B. Agenda

## 2.1 Approval of Agenda

**MOTION** by C. Leard and seconded by C. Mitsuk to approve the Agenda as prepared and circulated by our CAO prior to this meeting. All in favour. Motion carried.

#### C. Conflict of Interest Declaration

# D. Allocation of Surplus to Reserves – Note 8 Town of Souris March 31, 2025 Audited Financial Statement

Following presentation of March 31, 2025 Audited Financial Statement it was determined that the Town has some surplus money that can be allocated to Reserve Funds. The amount to be allocated is \$90,000. Discussion was held, some existing Reserve Funds were re-allocated along with the \$90,000. A copy of this breakdown is attached Pg 3.

### E. Consideration of Projects for CCBF- MSC

A couple of locations were discussed for water and sewer extensions. The goal for this funding is to create growth, especially in housing. It was determined that Council would like to pursue potential funding to extend the water and sewer lines on Beach Avenue.

MOTION by C. Outhouse and seconded by C. Laybolt that we pursue this MSC funding. Currently the water line ends at Allie Gallants house, and the sewer line ends at Craig Chapmans. Extending this service would not only service existing homes on this street but allow for the creation of many new serviced lots.

All in favour. Motion carried.

### F. Request for sponsorship of Goolaholla Festival

CAO to respond that with this late notice we are unable to provide sponsorship for 2025. Budget has been expended. Encourage them to submit their request earlier next year.

#### G. Safe and Active School Routes – GMF

MOTION by C. Laybolt and seconded by C. Outhouse that CAO to submit an application to this fund to install new sidewalks on the south side of Longworth and east side of LaVie. This would provide students walking from these residential areas safe off-street access to the lighted crosswalk at the main entrance to SRS. Currently students are left to walk on the street, and/or cross the street to get to the sidewalk. All in favour. Motion carried.

Council met last night to review the March 31, 2025 reserves (\$90,000), reallocate portions of the existing reserves, and add new reserve accounts while renaming some existing ones.

### Name changes and additions:

- Renamed Town Hall Reserves to Public Building Upgrades Reserves.
- Renamed Fire Hall Reserve to Fire Hall & Equipment Reserve
- Added Active Transportation Reserves
- Added Gateway Park Reserves.

#### Reallocation of current reserve funds:

- Water Tank: moved the full \$150,000 to Fire Hall Reserves.
- Alternative Energy: moved \$50,000 to Public Building Upgrades and \$50,000 to Gateway Park Reserves.
- Economic Energy: moved \$24,000 to Gateway Park Reserves.
- Special Events: moved \$3,100 to Active Transportation Reserves.

### Allocation of March 31st Reserves - \$90,000:

- \$40,000 to Fire Truck Reserves
- \$25,000 to Street Equipment Reserves
- \$25,000 to Active Transportation

Public Buildings Upgrades - \$60,000
Active Transportation - \$28,100
